

## **CARLA DUPUY PAPERS, 1982-1991**

### **ABSTRACT**

Carla DuPuy chaired the Mecklenburg Board of County Commissioners from 1984 to 1990. She also spent six years lobbying for Carolinas Healthcare System, eight years on the North Carolina Environmental Management Commission, and chaired the Charlotte Chamber's Environmental Concerns Committee. The focus of much of her community work was on children, education, healthcare, and the environment.

A large portion of Carla Dupuy's papers contains information on AIDS in the city of Charlotte in the late 1980's. Informational booklets, letters from community members, governmental reports, and other materials all make up this portion of the collection.

This collection contains documents, pamphlets, speeches, correspondence and reports.
