### ABSTRACT

Emma Peoples Smith was born in 1928 to James McDill (c. 1873-1939) and Mattie Perry Peoples (1892-1992). Her family included three sisters, Rachel, Margaret, and Perry, as well as two brothers, James and Preston. Primarily farmers, the Peoples family lived in the Providence section of south Mecklenburg County. They were early inhabitants of the region, beginning around 1790 with John Peoples, who was born in 1765 in the Shenandoah Valley in Virginia.
