The papers of **Walter Wilford Kale** (1897-1983) were donated to the Robinson-Spangler Carolina Room by his grandson, Wilford Wallace Kale of Williamsburg, Virginia in 2009.

W.W., as he was known in Charlotte, was born in Cleveland County and moved to Charlotte with his family at a young age. He began work as a salesman for Pound and Moore. In 1925 he partnered with his brother, Walker, and A. J. Lawing to form the Kale-Lawing Company, which sold office supply products from its store on 227 S. Tryon St until the 1980s.

The papers in this collection include personal financial records and correspondence, mementos and business records. The most extensive part of the collection derives from WW Kale's leadership of the Charlotte chapter of the Lions Club in 1936-1937, of the Charlotte Merchants Association in 1950-1951, and of the North Carolina Merchants Association in 1955-1956.
